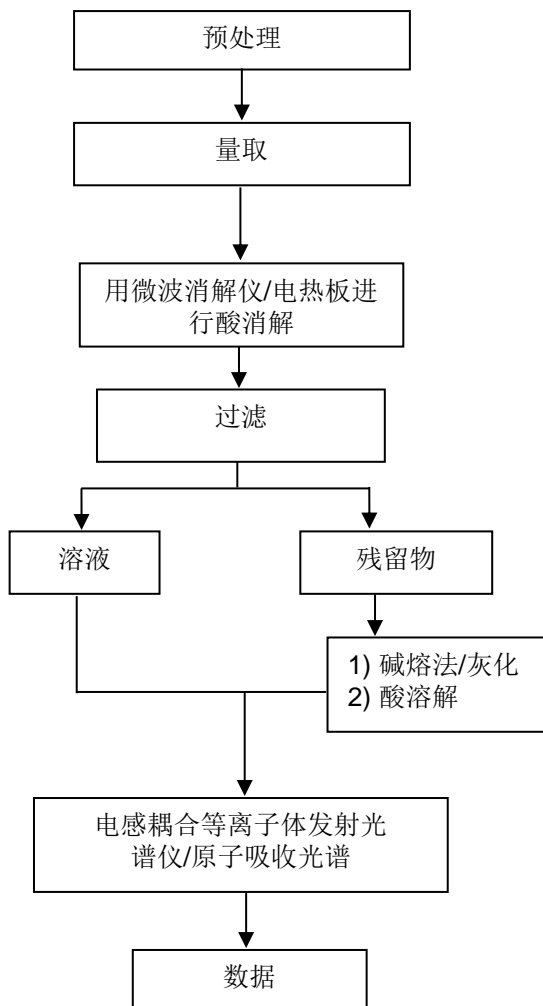

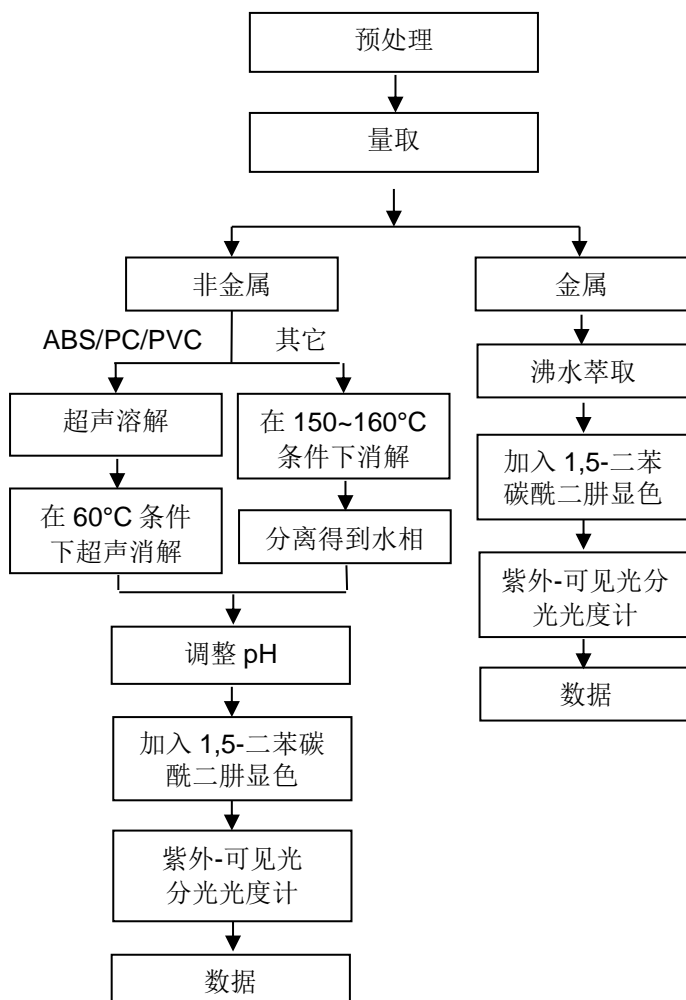

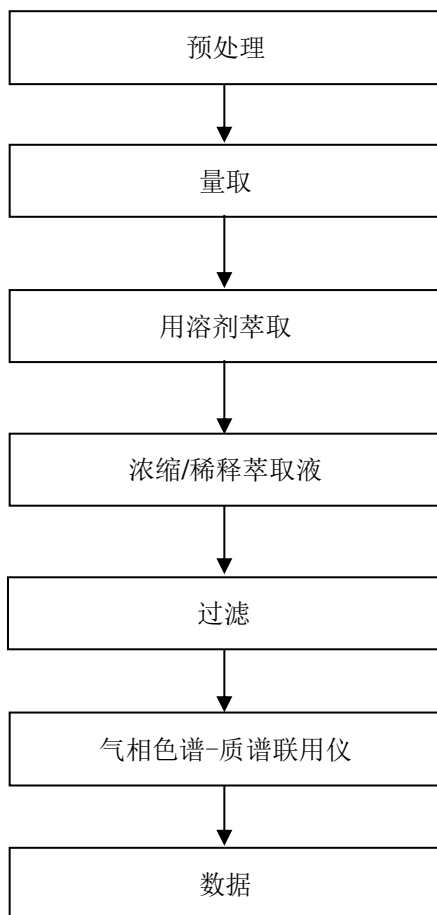


## 六价铬检测流程图





## PBBs/PBDEs 检测流程图



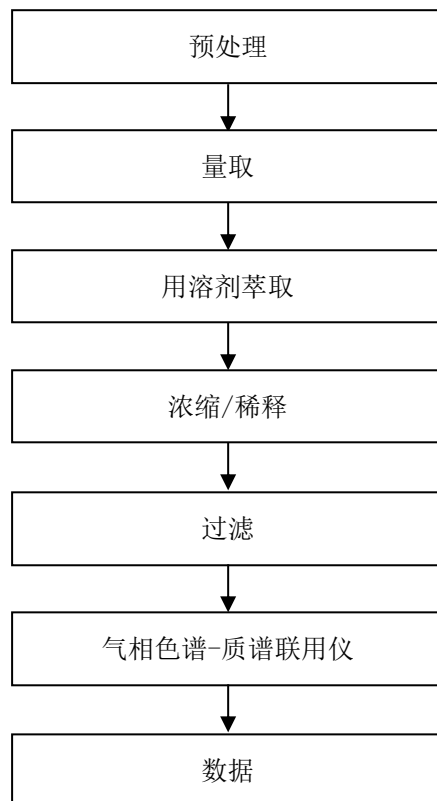
